John is currently in talks with Steve Lang regarding a new timing system which will enable the racers to wear a timing module and once they cross the finish line, it automatically calculates their information. We had a glitch in the system last year which we lost 99% of the times for the racers.

Sue brought up the fact that the CHS HOSA was to host a 5k but is planning to reschedule it next spring. She will email (cc'ing either John or Darla) the individual in charge requesting they not schedule in conflict with our race.

Currently, John, Darla, Susan Lani and LeAnn are heading up the entire 5k process. There was discussion of possibly having another CHS Senior participate as part of their Senior Project - all felt that it added more work to the process but will keep it under consideration.

Deanna provided a copy of the 2015 insurance form to John.

Darla has already requested the 4 Disneyland park hoppers as the Grand Prize for the raffle associated with the 5K. She will notify the committee once she hears back.

**d. Grad Night Student Surveys**

Student surveys are utilized by the committee to plan for the next year. 2014 surveys were not completed. With that said, there was discussion regarding surveying the current 2015 Seniors by either paper or Survey Monkey. This could be complete by visiting the different Government classes. Sue will contact the lead faculty for this and report back to the committee if this is feasible. Surveys would be completed in either February or March and survey topic ideas are to be brought forward to the November meeting (e.g., food, activities, 'Are you familiar with Safe Grad', prioritized list, etc.).
