We, the undersign, realize the business community and others have been very generous to provide the graduating seniors with a Safe Grad Party and trip to Six Flags Discovery Kingdom in Vallejo, California. In accepting this gift, we agree to abide by the rules set forth herein:

1. CHECK-IN IS STRICTLY BETWEEN 8:30 P.M. AND 10:00 P.M. DOORS CLOSE PROMPTLY AT 10PM AND NO ONE IS ADMITTED AFTER THIS POINT, UNLESS PRIOR WRITTEN APPROVAL IS GRANTED. REFUNDS WILL NOT BE GIVEN TO THOSE WHO HAVE PAID AND DON'T SHOW OR SHOW UP AFTER 10 P.M.
2. ONLY 2017 GRADUATES ARE ALLOWED TO ATTEND.
3. THE GRADUATE MUST ATTEND THE PARTY IN ORDER TO GO ON THE TRIP TO SIX FLAGS. GRADUATES MAY ATTEND THE PARTY AND NOT THE TRIP.
4. NO ALCOHOL OR DRUGS WILL BE BROUGHT TO THE PARTY OR ON THE TRIP.
5. NO ALCOHOL OR DRUGS WILL BE PURCHASED OR CONSUMED WHILE AT THE PARTY OR ON THE TRIP.
6. NO TOBACCO PRODUCTS WILL BE UTILIZED BY THOSE UNDER AGE 18 AND NONE WILL BE UTILIZED ON THE BUSES.
7. THE GRADUATE WILL RETURN TO CARSON CITY ON THE BUSES PROVIDED, UNLESS PRIOR WRITTEN APPROVAL IS GRANTED WHICH IS ON A RARE OCCASION. IF HE OR SHE DOES NOT, CARSON HIGH SAFE GRAD BOOSTER IS NOT RESPONSIBLE FOR RETURNING THE GRADUATE TO CARSON CITY.
8. THE PARENT/GUARDIAN CERTIFIES THAT HIS OR HER GRADUATE IS FULLY COVERED BY GROUP OR FAMILY MEDICAL INSURANCE.
9. WE UNDERSTAND THAT WHILE MOST OF THE COST FOR THE TRIP TO THE AMUSEMENT PARK HAS BEEN COVERED, THERE IS A FEE OF \$50 REQUIRED TO BE PAID PRIOR TO THE TRIP.

Your senior has asked to attend our drug and alcohol free, all-night party following the graduation ceremony on June 3, 2017. The event is designed to provide a fun and memorable experience that celebrates the culmination of the seniors' hard work and scholastic success. The Carson High Safe Grad Booster, the parents and community members responsible for planning this event, is committed to keeping it safe, drug, tobacco and alcohol free, and will take all reasonable steps to ensure that the conduct of all graduates is in keeping with this goal. All participants will be subject to a bag search and possible pat down before entering the facilities.

The graduate (if over 18 years of age) and/or their parent or legal guardian assume all risks associated with the attendance and participation at the graduation party and agree to hold each member of the Carson High Safe Grad Booster and its officers harmless from any and all liability claims of any nature which may arise in connection with the event. Furthermore, the graduation party is not a school sponsored event and Carson High School assumes no legal liability associated with the event.

Any graduate who engages in prohibited behavior including possessing or being under the influence of tobacco, drugs or alcohol, or engages in other undesirable conduct will be, at the sole discretion of the Carson High Safe Grad Booster, removed from the event. If this should occur, the parent/legal guardian(s) will be called and required to pick up the graduate from the party venue. No refunds will be granted. The graduate (if over 18 years of age) and/or their parent/guardian are liable for the full replacement cost of any and all loss or damage to any persons or property that is directly or indirectly caused by the graduate.

In case of emergency, authorization is given for all medical, surgical, diagnostic and hospital procedures as may be deemed necessary and performed by a treating physician. The graduate (if over 18 years of age) and/or their parent/guardian assumes responsibility for any expenses incurred as a result of accident, injury, illness and/or unforeseen circumstances requiring treatment.
